FARES AND ADDITIONAL INFORMATION

BASE FARE

STS has an established base fare of \$1.50. All fares are subject to change within a thirty (30) day prior notice.

SENIOR CITIZENS

With programs subsidized by the Pennsylvania State Lottery Program, seniors age sixty five (65) and older, can ride FREE all day with proper identification.

CHILDREN'S FARES

Children up to the age of eight ride FREE. Children between the age of nine and twelve can ride for \$.55 per trip. Thirteen and older are considered adults and must pay full fare. A maximum of three (3) children are permitted when accompanied by an adult.

TRANSFERS

ALL transfers are FREE! All passengers MUST request a transfer, IF APPLICABLE, from driver when boarding the vehicle to avoid paying full fare on connecting bus. Transfers are for use only in a continuous direction from point of origin to point of destination. Transfers will only be honored for the next available bus after receipt of transfer and are not valid for a return trip on the same route.

HOLIDAYS

No service provided Saturday, Sunday or the following holidays: New Years Day, Memorial Day, July 4th, Labor Day, Thanksgiving, Christmas Day.

- All vehicles are lift-equipped and 100% ADA compliant.

OTHER INFORMATION

- Have the exact fare. All bills must be unfolded.
- Smoking, eating or drinking is not permitted.
- Pull buzzer cord one half block from your stop to allow the driver time to safely slow down.
- Remain seated until bus comes to a complete stop.
- All strollers (umbrella type) and walkers with seats must be small in size, collapsible and passenger controlled.
- Carts are not permitted on buses since carts cannot be safely controlled by a passenger and pose a safety hazard to themselves and other riders on the bus.
- No items allowed in aisle at any time.
- Limit three (3) carry on bags per passenger.
- All buses lift equipped.
- Be courteous to your driver and fellow passengers.
- STS is not responsible for articles left on the vehicle.
- All passengers must adhere to STS policy as posted on vehicles.

BIKE RACK POLICY

All Schuylkill County Transportation Authority buses are equipped with front-mounted bike racks that hold two bicycles. There is no extra charge nor special permit or advanced reservation required to transport a bike on the bike rack.

- **ONLY BIKES THAT CAN BE PROPERLY SECURED ARE ALLOWED ON THE RACKS**
- **MOTORIZED BIKES WITH GASOLINE TANKS AND E-BIKES WITH LITHIUM BATTERIES ARE PROHIBITED**
- Be prepared to load your bike when the bus approaches.
- Make sure to inform the driver that you are using the rack. Drivers can instruct on proper use, but cannot touch your bike.
- You must load and unload your bike from the curb or in front of the bus.
- Remove any water bottles, pumps or other loose items.
